This form is used to determine your eligibility for additional services. Its intended solely to provide priority to Eligible Veterans & Eligible Spouses or Persons that meet certain criteria. This info is being requested on a voluntary basis & will be kept confidential. Refusal to provide the information will not subject you to any adverse consequences. **Mark all that apply below.** 

Veteran Status: Have you served on active duty 181 or more days, and do you have other than a dishonorable discharge? OR answer yes if: Exclusions to 181 day minimum active duty requirement: a) was discharged or released from active duty because of a service-connected disability b) was a member of a reserve component under an order to active duty during a period of war or in a campaign or expedition for which a campaign badge is authorized and was discharged or released from such duty with other than a dishonorable discharge or c) was discharged or released from active duty by reason of a sole survivorship discharge.

Are you the spouse of: 1) a totally disabled or deceased veteran whose disability or death was service-connected, or 2) of an active-duty service member who is currently listed as missing in action or forcibly detained by a foreign power or hostile entity for more than 90 days? Or are you the caregiver or family caregiver of a 100% disabled eligible veteran? Or are you the caregiver or family caregiver for a Wounded Warrior assigned to a Warrior Transitioning

## **Needs Determination for DVOP Services**

Currently homeless?

Been incarcerated?

Age 18-24 years?

Do you have a service-connected disability or pending claim? (Entitled to compensation from the VA or was discharged or released from active duty for a service-connected disability?)

Are you a Vietnam Era Veteran? This is defined as active military service in the Republic of Vietnam between February 28, 1961, and May 7, 1975, or service between August 5, 1964, and May 7, 1975.

Are you a transitioning service member who has who has not met career readiness standards and in need of individualized career services as indicated by a DD Form 2958, between the ages of 18-24, or is being involuntarily separated through a Service reduction-in-force?

Do you lack a high school diploma or equivalent certificate?

Unit (WTU) or Military Treatment Facility (MTF)?

Are you unemployed, or do you receive public assistance under one or more federal, state, or local income based public assistance programs; ex: TANF, SNAP (food stamps), SSI, or GA?

Are you a recently separated service member, who at any point in the previous 12 months has been unemployed for 27 or more weeks?

Are you a Wounded Warrior assigned to a WTU or MTF?
